Erection of a dwelling to include access arrangements at land to West of Rhandir, Penrhyncoch:

Following the special meeting held 2 January 2014, (separate minutes available) it had been resolved to object to the application: it was felft that numerous applications have been made by this applicant on the land, this application in particular was objected to on grounds of unsuitability and dangerous location of access.

- 1. Following the special meeting, the clerk stated that she had received an email from the applicant, Ms Mearina Owen to wished "to discuss some of the objections" with the Community Council in the January meeting. After consultation with the Chairman Ms Owen was informed that although she was permitted to attend the meeting as an observer she would not be permitted to speak unless granted by the Chairman. The chairman suggested that the matter be discussed in the January meeting, and if appropriate the applicant could perhaps attend the February meeting. The matter was discussed at length and a the decision to object was reiterated, and that this now concluded matters as far as the Community Council were concerned, and that the final decision lies with Ceredigion County Council
- 2. Cllr D Mason presented a letter to the clerk, informing the Community Council that the applicant Ms Mearina Owen had also contacted him (by Telephone)following the special meeting held on the 2<sup>nd</sup> January 2014. The nature of the telephone call was distressing, accusing Cllr Mason on mis leading the Community Council with negative comments in relation to her application in the special meeting held 2 January 2014 and that his actions would now be reported to the chief Executive of Ceredigion County Council.

The Community Council members present, and in particular the Chairman, stated that Cllr D Mason had not made any negative comments whatsoever and had kept completely neutral in his observations of matters in respect of the discussion regarding the planning application in front of the special meeting held 2<sup>nd</sup> January 2014

The minutes of the special meeting held 2<sup>nd</sup> January 2014, had been an accurate and true record of the discussions held.

It was resolved that should any communication be received from Bronwen Morgan, Chief Exec, Ceredigion County Council as a result of Ms Mearina Owen's complaint - he would be completely supported by the Trefeurig Community Council.
