Llwybyr Beicio/Cycle Path – Adroddodd y Cyng Mason am gwrthwynebiadau ynglun a'r llwybyr beico o Benrhyncoch i Gogerddan. Roedd un o'r trigolion yn y tai gyferbyn a chaeau'r Brifysgol yn gwrthwynebu gwneud i ffwrdd a'r clawdd ar ochr yr ffordd. Roedd Cyng Mason mynd i gwrdd a'r gwr gyda swyddog o'r Cyngor Sir. Dangoswyd cynllun i'r aelodau o'r cynlluniau gan Cyng Mason. Roeddy llwybyr yn croesi'r ffordd mewn un man peryglys iawn ger yr hen Ficerdy. Cytunwyd anfon llythyr o CC Trefeurig yn pwysleisio'r peryglon. Clerc i ysgrifenni.

Cllr Mason reported that there were objections to the removal of the hedge to create the new cycle path between Gogerddan and Penrhyncoch. One of the inhabitants of the dwellings opposite had written in opposition. Cllr Mason was to meet with the individual and an Officer from Ceredigion CC. Members were shown a plan of the path by Cllr Mason. It was noted that the path crossed the road in a particularly dangerous position. It was agreed to write to the council noting the dangers. Clerk to write.

The County Council replied to Trefeurig's letter 2 months after the date the letter was written. They accepted the validity of the complaint and would examine the site within 14 days of replying and the report back within a further 15 days.

Cllr Mason reported that Wales and West Housing had changed their plans to erect houses at the front of the site and bungalos at the back. Cllr Mason read out his letter to the planning officers asking them to ask Wales and West to reconsider and have the bungalos at the front of the site. It was agreed to write to the planning department asking if this meant that a new application would have to be submitted. Clerk to write.
