153 Cofnodion / Minutes Derbyniwyd fod Cofnodion y cyfarfod a gynhaliwyd 16.2.2021.

The minutes of the last meeting held 16.2.2021 were confirmed to be a correct record.

154 Materion yn Codi / Matters Arising

Golau Stryd/Street lighting – Gwirfoddolodd Cyng M Evans i gynnal adolygiad wedi cael y gwybodaeth priodol. Cytunwyd i'r Cyng R Owen cynorthwyo.

Cllr M Evans volunteered to review the lighting subject to receiving the appropriate guidelines. It was agreed for Cllr R Owen to accompany him.

Cwyn : Doedd dim diweddariad ar gael ynglun a chyflwr y ffordd ffrwyn yn dilyn o Tipynfarch i Bro Gynnin, ac hefyd fod yna weiren bigog ar un gat sydd angen tynnu ffwrdd.

Complaint : There was no update available in relation to the condition of the bridleway leading from Tipynfarch to Brogynnin, there was also a need to remove barbed wire on a gate.

Cllr D Mason reported that the application for the 5 Pods in Bancydarren had been refused with the recommendation that applicants re apply to move them closer to the farm.

Adroddodd Cyng D Mason mi fyddai cynnydd o 3.9% mewn treth y Cyngor.

Cllr Mason reported that there would be a 3.9% increase in Council Tax

Maes Seilo : Adroddodd Cyng D Mason fod ceudyllau mawr wedi ymddangod ar yr ystad, ac hefyd bod peth sbwriel wedi cael ei adael ar y maes parcio. Ceredigion i fonitro.

Cllr D Mason reported that some potholes have appeared on the estate and that some rubbish seems to have been left on the car park area. CCC to monitor.

Gorsaf Bow Street – Roedd yr orsaf newydd wedi ei agor erbyn hyn. Ni chafwyd gwahoddiad i'r Cadeirydd fynd i'r agoriad.

Bow Street Station – The station is now open and operational. No invitation was received for the Chairman to attend the official opening.

Salem – Adroddodd Cyng M Evans, fod angen torri clawdd Llwyn Prysg a fod arwydd Penrhiw ar goll.

Cllr M Evans reported that the hedge in Llwyn Prysg needs cutting back, and that the Penrhiw sign was missing

Peryg/Danger – Dywedodd Cyng R Owen ei fod wedi sylwi yn dilyn torri'r clawdd fod yna dwll mawr yn y clawdd wrth ymyl 6 Glanstewi, Penrhynoch a fedra achosi peryg i blentyn a phosiblwydd iddynt gwympo i'r afon. Clerc i gysylltu a Cyngor Sir Ceredigion a PCSO.

Cllr R Owen reported that following cutting of the hedge at 6 Glanstewi, Penrhynoch, a large hole has appeared which could cause danger if a child was to fall through into the river. Clerk to contact Ceredigion County Council and PCSO.
