The Clerk has contacted the council for information but has not yet received a response. Once the information is available Cllr M Evans and Cllr R Owen will undertake a survey of the area.

Cwm Symlog:

Goleuadau Stryd / Street Lights:

Gofynnodd Cyng C Roberts am gadarnhad mai goleuadau lefel isel oedd yr opsiwn a ffeirir ar gyfer y llwybr a rennir i IBERS. Cytunodd y cyngor fod hyn fwyaf addas ar gyfer yr ardal. Bydd Cyng C Roberts yn gwneud ymholiadau gyda Chyngor Sir Ceredigion.

Cllr C Roberts asked for confirmation that low level lighting was the preferred option for the shared path to IBERS. The council agreed that this was most suitable for the area. Cllr C Roberts will make enquiries with Ceredigion County Council.

Maes Seilo

Mynychodd y Cadeirydd, Cyng R Owen a Cyng C Roberts cyfarfod safle ar 21.06.2022 a siaradodd â thrigolion, sy'n ymwneud â chyflwr yr ardal barcio.

Cynigiwyd y syniad o greu llecyn gwyrdd gerllaw'r ardal barcio er mwyn gwneud yr ardal yn fwy dymunol gan Cyng C Roberts. Cyng C Roberts i ymgysylltu â'r preswylwyr i ddechrau'r broses o dacluso.

Bydd angen gwaith ar yr ardal barcio ei hun hefyd. Clerc i drefnu i'r 'handyman' Aled Jones ymweld â'r safle ac asesu pa waith sydd ei angen.

The Chairman, Cllr R Owen and Cllr C Roberts attended a site meeting on 21.06.2022 and spoke to residents, who are concerned by the condition of the parking area.

The idea of creating a green space next to the parking area in order to make the area more pleasant was proposed by Cllr C Roberts. Cllr C Roberts to engage with the residents to begin the process of tidying.

The parking area itself will also require work. Clerk to arrange for the handyman Aled Jones to visit the site and assess what work is needed.

Parc / Cwrt Tennis:

Aled Jones has visited the site to assess the damage caused to the path by the tree roots. The cost of repair to the path is estimated at £700. It was agreed that the work should be carried out.

30. Gwefan / Website:

Dywedodd Cyng L Emlyn ei bod yn teimlo bod angen i'r Cyngor wella'r ffordd maent yn cyfathrebu ar-lein er mwyn codi eu proffil a gwneud gwybodaeth yn haws i'w darganfod.

Roedd Cyng D James wedi ymchwilio i'r mater a rhoddodd grynoded o'r gofynion ar gyfer gwefannau Cyngorau Cymuned dan Arweiniad Statudol Llywodraeth Cymru ar Fynediad i wybodaeth am Gynghorau Cymuned a Thref (2015). Nid yw gwefan Trefeurig, sy'n cael ei defnyddio ar hyn o bryd, yn cwrdd â'r gofynion hyn.

Cytunwyd y byddai'r Cyngor yn gweithio ar ddatblygu eu gwefan eu hunain er mwyn cwrdd â'r gofynion hyn. Penderfynwyd felly y dylid cynnull is-bwyllgor Gwefan i symud y gwaith hwn yn ei flaen. Cynigiwyd penodi y Cadeirydd, Cyng L Emlyn a Cyng D James i is-bwyllgor y Wefan. Derbyniwyd y swyddi. Bydd is-bwyllgor y Wefan yn cyfarfod dros yr haf i greu briff ac i gael dyfynbrisiau ar gyfer y gwaith datblygu.

Cllr L Emlyn stated that she felt that the Council needs to improve how they communicate online in order to raise their profile and make information easier to find.

Cllr D James had researched the matter and gave a summary of the requirements for Community Council websites under the Welsh Government's Statutory Guidance on Access to information on Community and Town Councils (2015). The Trefeurig website, which is currently used, does not meet these requirements.

It was agreed that the Council would work on developing their own website in order to meet these requirements. It was therefore resolved that a Website sub-committee should be convened to move this work forward. It was proposed that the Chairman, Cllr L Emlyn and Cllr D James were appointed to the Website sub-committee. Positions accepted. The Website sub-committee will meet over the summer to create a brief and obtain quotes for the development work.

31 Rheolau Sefydlog / Standing Orders:

32 Deddf Llywodraeth Leol ac Etholiadau (Cymru) 2021 / The Local Government and Elections (Wales) Act 2021:

Rhoddodd Cyng D James grynodeb o ofynion Deddf Llywodraeth Leol ac Etholiadau (Cymru) 2021, sydd wedi dod i rym yn ddiweddar. Penderfynwyd rhoi'r Cynllun Hyfforddi ar yr agenda ar gyfer y cyfarfod nesaf.

Cllr D James gave a summary of the requirements of The Local Government and Elections (Wales) Act 2021, which has recently come into force. It was decided to put the Training Plan on the agenda for the next meeting.

33. Storfa Cae Chwarae Penbontrhydybeddau / Storage Penbontrhydybeddau Playing Field:

Siaradodd Mrs Ruth Davies i esbonio cynlluniau Cae Chwarae Penbontrhydybeddau i godi adeilad dros dro ar y maes storio a chyfarfodydd pwyllgor. Dymunai'r Pwyllgor gael cymeradwyaeth ar y cynlluniau hyn gan Gyngor Cymuned Trefeurig fel perchennog y tir.

Cytunwyd bod y Cyngor yn hapus i'r cynlluniau hyn fynd ymlaen.

Mrs Ruth Davies spoke to explain Cae Chwarae Penbontrhydybeddau's plans to erect a temporary structure on the field for storage and committee meetings. The Committee wished to gain approval for these plans from Trefeurig Community Council as the owner of the land.

It was agreed that the Council was happy for these plans to go ahead.
